

### APPROVAL OF MINUTES

#### **OLD BUSINESS:**

- a. Appointment of a Secretary: Motion made by Vicky to appoint Kellie Neal, 2<sup>nd</sup> by Jeff. Motioned passed.
- b. Disc Golf Course: One goal possibly damaged and one needs to be relocated due to new drive installed last year. Jeff suggested a visual inspection of each one and possibly guidelines and a map posted. Jeff to contact Jody Hughes to ask for his assistance in goal placement. Discussed ordering flags and stickers for the disc golf. Vicky to get a price and present next meeting
- c. Fence Around Soccer Field: Soccer commissioner discussed concerns about soccer balls going into ditch and pond. Discussion of an orange temporary fence to extend the fenced area to keep this from happening. Motion made by Vicky to allow use of a temporary fence as soccer league is responsible for mowing and maintenance. Kellie 2<sup>nd</sup>. Soccer Commissioner asked board to revisit a request to add sponsorship signage for the season. Jeff to discuss at the next city council meeting. Discussed concerns of two large holes in the ground on the soccer field that have been filled but keep caving in.
- d. Discussion of Potential Board Members: Both Vanessa Schmitt and Gena Hish are interested in becoming board members.

#### **NEW BUSINESS**

- a. Event Planning: June 7 Gospel Signing at Baker Park from 4:00pm to 7:00pm Discussion of selling concessions (hamburgers, hot dogs, chips), discussion of renting a foam pit for the event. Kellie to check on pricing. Jeff is contacting several people in order to line up singers. Will finalize at our next meeting
- b. Discuss continuation of board FB page, delegate an administrator. Vicky agreed to continue to be the administrator
- c. Discuss needed projects (possible specific fundraisers)
  Extension of fences to prevent soccer balls rolling into the wood and lake: Soccer commission has asked to put up a temporary fence at the expense of the soccer league. This will be taken down after each season
  Gutter on pavilion (splash pad side). Motion was made by Kellie Neal for Park Board to pay 50% of the expense. Motion was not passed.

Resignation of Meghan Harvey accepted. Both Vanessa and Gena's names will be submitted to the city council to vote on for Park board members.
