

OLD BUSINESS

a. Playground equipment in need of repair or removal (merry go round, balance beam)

Brian has emailed twice about a replacement for balance beam, no response. Both are tabled for the next meeting.

A. Appoint Secretary

Appointment of Vicky Tillman as Secretary, with Amy Oakley as backup. Motion, Brian, 2nd Rachel Unanimously approved.

B. Approve payment of pump and float for spray park.

C. Discussion of spray park and equipment

Matthew Wright met with Matt Cobb to look at the equipment and the Spray Park.

- The current parts (mushroom, fire hydrant, arch) are PVC and rated as Lite Commercial). The mushroom has broken twice, been repaired, but when it broke, left sharp edges that could cause a serious injury if a child fell on it.
- Need to look at insurance coverage (per incident, total for park)
- Look into adding color coating to the waterpark deck to also include some type of texture to prevent slips.
- Look into replacing the parts with stainless parts, which are approx. 5,000 each. Look into fundraising and replacing one part each year.
- There is a lot of water loss due to run off and to wind blowing water off the deck. Will check with Dylan Blandford for estimate on building up the apron on 3 sides. Matt will follow up with estimates.

Short Term:

- Cameras are not currently working. Follow up with Barb about the cameras.
- Can the current items for spray park be reinforced to make them stronger to prevent breaking?
- Can there be a daily visual inspection of the parts to identify were any have cracked?

Decisions:

1. Put back up the 2 pieces (U shaped arch which attaches in two places and the fire hydrant now. Verify everything is included in the posted signs to ensure safety, repair or replace cameras on the water park and have a daily checklist to check equipment.

2. Matthew to obtain estimate from Dylan Blandford for concrete work.
