Monday, December 9, 2024, 6pm

Dixon City Commission met in session Monday, December 9, 2024, 6 p.m. Attending were Mayor Dorris Crowley, Commissioners Terry Webb, Randy Norman, Jeff Graham, and Peggy Poole, City Clerk Barb Goff, and Code Enforcement Board Chair Sondra Norman. Also in attendance was Robert Brown.

Minutes were approved on a motion by Commissioner Webb, seconded by Commissioner Graham, all ayes.

Bills were approved on a motion by Commissioner Poole, seconded by Commissioner Norman, all ayes.

Water loss was at 9.4% in November. Dixon Waterworks completed a system-wide flush during that time.

Dixon Fire Department completed 24 runs in November.

A motion to accept the resignation of Code Enforcement Officer Jessica Veach was made by Commissioner Graham, seconded by Commissioner Webb, all ayes. CEB Chair Mrs. Norman noted the Board will continue to meet and proceed with currently active cases, and will be seeking a new Code Enforcement Officer.

A second reading to repeal Ordinances 110.01-110.09 in regards to business licenses was approved on a motion by Commissioner Norman, seconded by Commissioner Poole, all ayes.

Commissioner Webb made a motion to rehire City Attorney Lindsay Durbin for the 2025 year, to be reviewed in December, seconded by Commissioner Graham, all ayes.

Commissioner Webb made a motion to allow employees to carryover accumulated vacation and sick leave hours to the new calendar year, seconded by Commissioner Poole, all ayes.

As the Tourism Board is presently incomplete and cannot make their own approvals, Commissioner Graham made a motion to approve reimbursement requests, which were expenses related to the Veterans Day event, from the Tourism Board, seconded by Commissioner Norman, all ayes.

Commissioner Webb made a motion to approve the use of Tourism funds for the prizes and judging gifts related to the City's annual Christmas Decoration Contest, seconded by Commissioner Graham, all ayes.


Commissioner Poole made a motion to table board appointments until the regular January meeting, seconded by Commissioner Norman, all ayes.
