Monday, January 8, 2024, 6pm

Dixon City Commission met in session Monday, January 8, 2024, 6 p.m. Attending were Mayor Dorris Crowley, Commissioners Terry Webb, Randy Norman, Jeff Graham, and Peggy Poole, City Clerk Barb Goff, Code Enforcement Board Chairman Sondra Norman, and Code Enforcement Officer Jessica Veach.

Minutes were approved on a motion by Commissioner Webb, seconded by Commissioner Norman, all ayes.

Bills were approved on a motion by Commissioner Poole, seconded by Commissioner Graham, all ayes. Mrs. Poole noted that the spray pad at Baker Park operated in 2023 at an expense in excess of \$6,000, and requested the City find ways to curb that cost.

Water loss is down to 16.59%, and this month's payment to Webster County Water District is the lowest amount in several years. The water salesman dispensed 68,500 gallons during 2023, and did not operate at a loss for the first time in several years.

Dixon Fire Department completed 20 runs in December, with a total of 173 runs for 2023.

Commissioner Webb reported four of the six Park Board members have resigned.

Mrs. Veach reported one code enforcement case has been referred to WC Health Department, and several notices for repeat offenders will be mailed soon.

A motion to accept a bid from Kenergy for the Kenergy franchise was made by Commissioner Graham, seconded by Commissioner Webb, all ayes. A motion to authorize the mayor to sign related documents was made by Commissioner Poole, seconded by Commissioner Webb, all ayes.

This year's Commission Committee Appointments, which switches Mr. Graham to Park and Mr. Webb to Streets, was approved on a motion by Commissioner Norman, seconded by Commissioner Poole, all ayes.



Code Enforcement Board appointments were approved on a motion by Commissioner Webb, seconded by Commissioner Graham, all ayes. All current members were renewed for three years.

Commissioner Norman made a motion to enter closed session in regards to Personnel (KRS 61.810 f), seconded by Commissioner Webb, all ayes. Commissioner Webb later made a motion to resume public meeting, seconded by Commissioner Norman, all ayes. There was no report.
