Monday, January 13, 2025, 6pm

Dixon City Commission met in session Monday, January 13, 2024, 6 p.m. Attending were Mayor Dorris Crowley, Commissioners Terry Webb, Randy Norman, and Peggy Poole, City Attorney Lindsay Durbin, City Clerk Barb Goff, Code Enforcement Board member Stace Poole, and resident Robert Brown.

Following the recent election for the new term of Commissioners, a vacancy was created on the Commission. Commissioner Norman made a motion to appoint Robert Brown to fill the vacancy, seconded by Commissioner Webb, all ayes.

Clerk Goff administered the oath of office to Mr. Brown, and he was seated with the Commission.

Minutes were approved on a motion by Commissioner Webb, seconded by Commissioner Poole, all ayes.

Bills were approved on a motion by Commissioner Norman, seconded by Commissioner Webb, all ayes.

Water loss for December was 16.34%, and the average water loss for the 2024 calendar year was 20%.


Dixon Fire Department completed 11 runs in December.


Mayor Crowley announced that he is no longer a resident of the City of Dixon, and as he no longer meets the qualifications for office of Mayor, he intends to present a letter of resignation before the end of the month. Mayor Crowley expressed gratitude for serving the City and complimented the Commission members on their teamwork during his service. In consideration of the forthcoming resignation, Mayor Crowley asked for a motion to table board appointments, committee assignments, and check signing authorizations until a new Mayor was appointed. Commissioner Poole made the motion, seconded by Commissioner Webb, all ayes.

A called meeting was scheduled for January 27 at 5pm.

Commissioners discussed the need to purchase new Christmas decorations and the current opportunity for after-season sales. Commissioner Brown made a motion to authorize up to \$7,500 from the General Fund to purchase lighted pole mounted decorations and banners, seconded by Commissioner Norman, all ayes.

A motion to adjourn was made by Commissioner Webb, seconded by Commissioner Norman, all ayes.

Monday, January 27, 2025, 5pm

Dixon City Commission met in session Monday, January 27, 2024, 5 p.m. The meeting was called as a result of the resignation of the Mayor, and for continued discussion/action on the proposed merging of the Park and Tourism Boards. Attending were Commissioners Terry Webb, Peggy Poole, and Robert Brown, City Attorney Lindsay Durbin, City Clerk Barb Goff, and Dixon resident Cletis Woodring Jr.

Commissioner Poole made a motion for Commissioner Webb to serve as presiding officer for the meeting, seconded by Commissioner Brown, all ayes.

Following Commissioner Webb reading a letter of resignation from Mayor Dorris Crowley, Commissioner Brown made a motion to accept the resignation, seconded by Commissioner Poole, all ayes.

Commissioner Poole made a motion to appoint Terry Webb to fill the mayor vacancy, seconded by Commissioner Brown, all ayes. Clerk Goff administered the oath of office for the new mayor. An appointment to fill the now vacant Commissioner seat is expected to be made at the February meeting.


Mayor Webb made a motion to appoint Commissioner Poole as Mayor Pro Tem and the Administrative Committee, Commissioner Norman as the Water Committee, and Commissioner Brown as the Street Committee, seconded by Commissioner Brown, all ayes.

Commissioner Brown made a motion to approve Mayor Webb, Mayor Pro Tem Poole, and City Clerk Goff as authorized check signors for all City bank accounts, seconded by Mayor Webb, all ayes.

Items on the agenda included discussion of a proposed merge of the Park and Tourism Boards, and appointments to those boards if necessary. The Commission decided to appoint members to the Park Board and see if they are willing to accept additional responsibilities of a tourism nature prior to deciding on a direction for the Tourism Board. Commissioner Poole made a motion to appoint Vicky Tillman, Eddie Branson, Meagan Harvey, and Jeff Graham to the Park Board, seconded by Commissioner Brown, all ayes. Clerk Goff will reach out to the members to schedule a Park Board meeting.

A motion to adjourn was made by Commissioner Brown, seconded by Commissioner Poole, all ayes.
